St Anne's Primary School, Denton Equality Scheme 2022-2025 (1.6)

1. <u>Statement</u>

This scheme outlines the commitment of the staff and Governors of St Anne's Primary School to promote equality.  - ethnicity,
 - religion or belief, and
 - socio-economic background.

2. Statutory requirements

• Current issues affecting cohesion at school, local and national level

Very low percentage of children from minority ethnic groups means children have limited opportunities to mix with children from wide range of cultural backgrounds in school situation. This is being addressed in our school development priorities as part of cultural capital.

4. <u>Responsibilities</u>

One named governor, Brenda Moxon (Inclusion Governor), takes the lead, but the **governors** as a whole are responsible for:

- drawing up, publishing and implementing the school's equality objectives
- making sure the school complies with the relevant equality legislation; and
- making sure the school Equality Scheme and its procedures are followed
- monitoring progress towards the equality objectives and reporting annually

The head teacher is responsible for:

- making sure steps are taken to address the school's stated equality objectives;
- making sure the equality, access and community cohesion plans are readily available and that the governors, staff, pupils, and their parents and carers know about them;
- producing regular information for staff and governors about the plans and how they are working;
- making sure all staff know their responsibilities and receive training and support in carrying these out; and
- taking appropriate action in cases of harassment and discrimination, including prejudicerelated incidents.



• anticipating and enabling reasonable adjustments to be made, in relation to disability, in regard to students, staff, parents / carers and visitors to the school.

All staff are responsible for:

- taking up training and learning opportunities.
